## Available Financial Relief Programs

### CARES Act- Provider Relief Fund

U.S. Department of Human & Health Services has begun distributing the remaining \$20 billion of the \$50 billion general distribution to Medicare providers proportional to providers' share of net patient revenue.

### Economic Injury Disaster Loan Emergency Advance

This loan advance will provide economic relief to businesses that are currently experiencing temporary difficulties.

### Paycheck Protection Program

The Paycheck Protection Program is a loan designed to provide a direct incentive for small businesses to keep their workers on the payroll.

SBA will forgive loans if all employees are kept on the payroll for eight weeks and the money is used for payroll, rent, mortgage interest, or utilities.

### HHS Skilled Nursing Relief Fund

The Skilled Nursing Relief Fund will provide financial relief for eligible skilled nursing facilities to assist them in addressing the effects of the COVID-19 pandemic. The \$4.9 billion distribution will support nursing homes suffering from significant expenses or lost revenue due to COVID-19.

### SBA Debt Relief

The SBA is providing a financial reprieve to small businesses during the COVID-19 pandemic.
