## **Intellectual and Developmental Disabilities Comprehensive Managed Care (ICMC) Program**

ICMC is a statewide Medicaid program that provides people with intellectual and developmental disabilities, all their regular healthcare services plus additional home and community-based services. Florida Community Care (FCC) was selected to be the sole managed care plan operating the Program.

Who is Eligible for the ICMC:

- Individuals who are 18 years or older in pre-enrollment list for the iBudget Waiver
- Individuals residing in Florida
- Individuals who are on or eligible for Medicaid.
