TECARTUS™ (brexucabtagene autoleucel)

LENGTH OF AUTHORIZATION: Date of service

ADMINISTRATION: Hospital inpatient or outpatient setting

REVIEW CRITERIA:

• Patient must be 18 years of age or older.

- Must have relapsed or refractory mantle cell lymphoma (MCL) **OR** relapsed or refractory B-cell precursor acute lymphoblastic leukemia (ALL).
- Must have tried and failed at least two lines of systemic therapy.

DOSING:

- Because of the risk of Cytokine Release Syndrome (CRS) and neurological toxicities, Tecartus is available only through a restricted program under a Risk Evaluation and Mitigation Strategy (REMS) called the Yescarta and Tecartus REMS program.
